The Workforce Innovation and Opportunity Act (WIOA) of 2014 supersedes the Workforce Investment Act (WIA) of 1998 and encourages coordination of core programs. WIOA emphasizes work-based learning and career pathway systems and increases outreach to disconnected youth. The following programs are required to deliver their services through the One-Stop system:

- Workforce Innovation and Opportunity Act
- Job Corps
- Native American Program
- Wagner-Peyser (Employment Service)
- Unemployment Insurance
- Trade Adjustment Assistance
- Senior Community Service Employment
- Veterans Employment and Training
- Vocational Rehabilitation
- Adult Education
- Post-secondary Vocational Education
- Community Service Block Grant Employment and Training Activities
- Housing and Urban Development Employment and Training Activities

One-Stop Centers in Arizona are defined in the following ways:

Comprehensive One-Stop Center - The basic services of the above listed partner programs are available on-site. This includes co-location of most staff from these programs.

Affiliate Site - Most of the basic services of the required partners are available on-site. These can be facilities operated by one program, but with other partner staff on-site. Information on the above listed partner programs are also available at this location.
